III. Guideline for data validation and usage

1. Change of sector: In view of that there are only two domestic tobacco manufactures currently and the minimal risk of data disclosure, the Directorate General of Budget, Accounting, and Statistics has put tobacco manufacturing industry under the beverage manufacturing industry starting from July 2009. Information on the number of employees, salary, working hours, and entry and exit rates for the tobacco manufacturing industry has therefore been incorporated to protect individual manufacturers from being disclosed.
2. Since January 2009, “educational services (only short-term supplementary educational programs and driving schools)” and “social work services (only child and infant day care)” have been added into the Industry, Commerce and Service.
3. The column widths of variable label and value description in the STATA are limited to 80 and 40 bytes, respectively, so the STATA dataset shows only the

first 80 bytes as variable label, and the first 40 bytes as value description. Likewise, SPSS and SAS datasets only show the first 256 characters as variable label and the first 120 ones as value description. In case of cut-off contexts, please see code book.

4. CSR has checked wild codes and out-of-range values, to validate and clean data. There is no doubt about data accuracy after the validation.
5. Please be attentive if “system missing” may not be listed in the variable value because of the design of skip question (N/A), missing/no response and so on.
